

Financial Notice Removal of the SRI label and change of name

The new guidelines relating to the government SRI label "version 3.0" now incorporate a climate component into their base, and reinforce selectivity on environmental, social, societal and also governance criteria. These new criteria will have an impact on the investment universe of certain asset classes, in particular through the introduction of new exclusion rules for certain sectors.

In this context, Amundi Asset Management would like to advise unitholders and shareholders of the following Undertakings for Collective Investment ("UCIs") that these UCIs will no longer benefit from the SRI label:

- AMUNDI ENHANCED ULTRA SHORT TERM BOND SRI
- AMUNDI EURO LIQUIDITY SRI
- AMUNDI FRANCE ENGAGEMENT
- AMUNDI VIE ISR
- AMUNDI AMBITION NET ZERO CARBONE
- LCL INVESTISSEMENT DYNAMIQUE ISR
- LCL INVESTISSEMENT EQUILIBRE ISR
- LCL INVESTISSEMENT PRUDENT ISR

These UCIs will nevertheless retain their non-financial approaches and their exclusion rules based on sustainability criteria.
