Dear Unitholder,

The Board of Directors of Amundi SGR S.p.A., acting as management company of Amundi Soluzioni Italia (the “Fund”), would like to inform you of the following changes in the prospectus of the Fund (the “Prospectus”):

1. Change of the name of sub-funds

The current denomination of the following capital protected sub-funds of the Fund (the “Sub-Funds”) includes the term “ESG” only as a reference to the underlying index that is used in the formula of the Sub-Funds to calculate the coupons and the maturity price as described in the Prospectus. Insofar the Sub-Funds do not actually promote Economic, Social and Governance (“ESG”) factors in their respective investment policies, it has been decided to remove the term “ESG” from their names and to change their denomination as follows, with effect as of 6th May 2024:

Consequently, any reference made to the Sub-Funds in the Prospectus will be updated accordingly. The above change of name of the Sub-Funds does not impact the underlying index which shall remain unchanged.

In addition, since the item 39. “ESG Denominated Capital Protected Sub-Funds” of the section “Special Risk Considerations” of the Prospectus currently only refers to sub-funds with an “ESG denomination”, this item will also be updated in order to clearly disclose that this item applies to sub-funds referring an ESG index in their respective investment objectives and policies, to the extent that these sub-funds are designed to provide a return linked to an ESG index but do not follow an ESG investment process for the purpose of construction of their own portfolios.

It is not expected that the above changes will have any impact on the other features of the Sub-Funds such as the level of fees charged to the Sub-Funds, or their investment objectives and policies.
