Financial Advice Compliance with ESMA guidelines known as Fund Naming and Name Change

Unitholders of the **AMUNDI Ultra Short Term Impact Green BOND*** mutual fund (FCP), managed by Amundi Asset Management, are informed of the following changes effective

In application of the new European guidelines (ESMA 34-472-440), published on 14 May 2024, on the names of funds using terms related to environmental, social and governance (ESG) criteria or sustainability, companies that derive a certain part of their turnover from fossil fuels (gas, oil, etc.) will be excluded from the fund's portfolio (these are the exclusions provided for in Article 12, points (a) to (g) of paragraph 1 of Commission Delegated Regulation (EU) 2020/1818 of 17 July 2020 supplementing Regulation (EU) 2016/1011 of the European Parliament and of the Council).

The FCP will nevertheless be able to invest in bond issues intended to specifically finance green, social and/or sustainable projects, issued by companies linked to activities considered non-aligned with the Paris Climate Agreement.

In addition, AMUNDI ULTRA SHORT TERM IMPACT GREEN BOND will change its name to "AMUNDI IMPACT ULTRA SHORT TERM GREEN BOND".

These changes are not subject to approval by the Autorité des Marchés Financiers (AMF) and do not involve any specific action on your part.

The other characteristics of your fund remain unchanged.

We invite you to read the Key Information Documents (KID) and the prospectus of the AMUNDI ULTRA SHORT TERM IMPACT GREEN BOND fund, which will be updated to take account of these changes, on the <u>www.amundi.fr</u> website as of February 28, 2025.
