Investment Minimums

The minimum initial purchase amount for an Amundi US Class A or Class C shares fund can be located within the fund’s prospectus.

For accounts established with an Automatic Investment Plan, the minimum initial purchase is \$50 per fund for all funds except the Pioneer U.S. Government Money Market Fund, which has a minimum initial investment amount of \$100.

Share Class Descriptions and Sales Charge Information

Class A Shares: are available to all investors who meet the fund minimum.

Class A shares of equity and asset allocation funds have a maximum 5.75% sales charge at the beginning of the period. Class A shares of fixed income* and balanced/flexible funds have a maximum 4.50% sales charge at the beginning of the period. Class A shares of Pioneer U.S. Government Money Market Fund do not have a sales charge.

Class C Shares: are available to all investors who meet the fund minimum.

Class C shares of all funds** have a 1% contingent deferred sales charge that applies to redemptions made within one year of purchase.

Class R Shares: are available to certain tax-deferred retirement plans (including 401(k) plans, employer-sponsored 403(b) plans, 457 plans, profit sharing and money purchase pension plans, defined benefit plans and non-qualified deferred compensation plans) held in plan level or omnibus accounts. Class R shares also are available to IRAs that are rollovers from eligible retirement plans that offered one or more Class R share Pioneer funds as investment options and to individual 401(k) plans, including the Individual(k)TM Plan.

Class R shares are not available to non-retirement accounts, traditional or Roth IRAs, Coverdell Education Savings Accounts, SEPs, SAR-SEPs, SIMPLE IRAs, individual 403(b)s and most individual retirement accounts or retirement plans that are not subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Class R shares of all funds do not have a sales charge or contingent deferred sales charge.

Note: All the Pioneer funds and share classes listed here may not be available through your financial professional’s firm. Contact your financial professional for additional information.

* Effective February 5, 2018, there will be no sales charge on purchases of Class A shares of Pioneer Multi-Asset Ultrashort Income Fund and Pioneer Short Term Income Fund.

* Effective November 8, 2021, there will be no sales charge on Class A share purchases equal to or greater than \$250,00 of Pioneer AMT-Free Municipal Fund and Pioneer High Income Municipal Fund.

** Class C shares of Pioneer Multi-Asset Ultrashort Income Fund and Pioneer Short Term Income Fund do not have a 1% contingent deferred sales charge.
